Similarly, we hold facilities and expertise to inspire software projects and digital arts.

### Workshops

The funding will enable us to expand our program of workshops, both improving content and covering a wider range of subject areas. Investment in tooling and the ability to subsidise materials will enable us to expand the reach and quality of events.

## **Arts and Creative Support**

We aim to provide a meaningful contribution to art and events within the city, such as Nuart, Spectra and Open Doors Day. This will allow our members, and members of the community who participate, to learn or further develop STEM skills.

#### **Festivals**

We are a membership run organisation and our aims are based on providing a community owned space focused on technology and creativity as a social enterprise. We practise an asset lock, ensuring all income is invested in the betterment of our facilities for the benefit of the community. No members or directors receive an income or payment of any activities related to the organisation.

Our core aims are as follows:

- Our mission is to promote and and encourage technical, scientific and artistic skills and innovation through individual projects, collaboration and education, driven by a strong culture of self education.
- We aim to provide open events to allow the wider technical and creative communities in Aberdeen to meet, socialise, share ideas and facilitate collaboration.
- We actively promote and support the use, development and release of free and open technologies, data, standards, ideas, hardware and software for the benefit of all.
- We strive to provide a shared physical workspace, tools, storage, guidance and other resources for members and the wider community.

Our membership is made up of a diverse range of driven creatives from many backgrounds - software, electronic design, wood and metal work and more. In line with our organisational goals, we aim to foster a culture of technological literacy, creativity and agency.

Our membership have travelled Scotland, Europe and the World to share our values, projects and experience with others, presenting at conferences such as Chaos Communication Congress in Germany, EMF Camp in England, SHA Camp in the Netherlands and Maker Faire Edinburgh. Within Aberdeen, we have supported Mayfest, Techfest and IET Outreach events at Aberdeen Science Centre by providing interactive exhibits, directed workshops for all ages covering the basics of soldering and basic electronic projects.

Most recently we completed a series of workshops and lectures as part of a global project, originating from Stuttgart, monitoring and analysing air quality. We are actively providing free public lectures and workshops, tied with one-on-one sessions at our location discussing and sharing the hardware and software of the sensors. In participating with this project, we have collaborated with both Robert Gordon's University, Gray's School of Art and the space formerly known as Make, Aberdeen.

#### 4. Application Questions

## Tell us more about the activity and what do you want to achieve with this support?

We aspire to provide a physical location for the bridging of creative industries in Aberdeen. With Make on Belmont Street closed, the loss of the resources available at that space leaves aberdeen wanting in publicly accessible digital arts facilities. The funding, if successful, would be mainy put to use to buy equipment for the public use and ensure the facilities are up to standard. it will also allow us to further market the space and increase the public perception of Aberdeen's provision for Digital Arts and Creativity.

We have previously been involved in events and festivals in the city and abroad, the funding will allow us to take further risks in the scope and improve the impressions from our participation, we are financially restricted in our participation, with money to fund our participation we will be able to be more ambitious in what we do, and inspire greater creativity.

We currently work with the Open Rights Group to provide a monthly session, called "Cryptonoise" focused on teaching any interested individuals or organisation the fundamentals and advanced aspects of personal digital & information security, using technologies such as encryption to secure and store information, and to promote understanding why personal phone, computer and network security are critical in the modern digital age. We have presented lectures on personal security at other events in the city, including Techmeetup, but being able to afford larger venues and fund promotional materials (flyers and online, for example meetup.com) would greatly increase our ability to offer these events to a larger and more diverse audience.

We would like to expand our Air Quality Monitoring workshops and events that we have been running. By funding equipment, we hope to be able to engage both individuals and local organisations to help improve the quantity and quality of data recovered, improve the design of the air quality monitoring unit and work with organisations within the city, for example the universities or the council, to provide new types of data for academic and civic study. We would love the opportunity to fund and work with artists to create new interpretations of the data and increase public awareness of the study and research that is ongoing also.

Our own internal workshops and events would be greatly enhanced with additional funding - for example, our annual Game Jam, a video game development competition, would see greater attendance and investment with improved marketing, the ability to provide prizes and food for participants for the duration of the event to provide a more professional, organised feeling. Similarly, our open data sessions - Open Street Map workshops and Linux development weekends would benefit from creating a more welcoming environment and improved advertising, attracting more members and talent to grow our community.

Where we collaborate with other local groups and artists, improved facilities and greater publicity of the space will provide a bridge between the arts and creative community and the Tech community. Combining the increasingly diverse range of industries within Aberdeen with the technological proficiency of the population, we see a resource of technical expertise which could, if nurtured, add a distinct flavour to the creative industries coming out of our region. We would like to provide workspace and inspiration for technologists and creatives to collaborate, providing unique opportunities for innovation.

## Who is your target participant and/or audience group(s) for this project?

We see three distinct audiences for our Work.

#### **General Public**

This can be subdivided into local populations and the public outside Aberdeen, this local population should have a feeling that the city is active and vibrant, Nuart and Spectre had been pushing these frontieres, which we support. To be able to provide a hub for digital creativity in the city, would give an impression of constant activity in these areas, we would use our involvement in the already established festivals, and our own workshops to inspire and entertain the general population.

Outside Aberdeen our continued involvement in camps, conferences and international projects, will show to world that Aberdeen is capable when it comes to digital arts and creativity. This would raise the profile of Aberdeen internationally and draw more attention and potential creatives to the city.

#### **Technologists & Creators**

Aberdeen is currently undergoing a radical transition to become an international hub for a variety of industries. We feel having a location which allows the technologists and creators in aberdeen access to the creative industries would ease and accelerate this process, drive personal and professional development through peer learning and allow others the opportunity to use their skills to develop our city and community culturally.

## **Artists and Creatives**

In our space we would like to see the participation of the creative communities in the wonders of digital arts, with the special demographics of aberdeen it would be a shame for the work that Make did in Belmont Street to be eroded. Through working in collaboration with the artist communities in aberdeen, we see the space as a central location to aid artists in the city exploit the technological strengths of the population, continuing the legacy of Make.

Our Statement on Equality and Diversity is: "57North Hacklab Ltd welcome and encourage participation by everyone. Our community is based on mutual respect, tolerance, and encouragement, and we are working to help each other live up to these principles. Whoever you are, and whatever your background, we welcome you."

We offer our facilities and workshops for free to those who require them, and endeavor to ensure the events are open and accessible to everyone, We have previously worked with the central library, to ensure the location or our workshops are accessible for the disabled. One of the deciding factors of the new space locations was accessibility.

As an organisation we recognise a gender bias within the technology community, and while this is visible in our own membership we strive to provide a respectful, open and welcoming environment to all.

We hope, over the coming year, to run a wider range of events which will capture the imagination of a more diverse community. With advertising and support, we would like to host public events celebrating Women in Science day, LGBT STEM Day and, through having a more diverse community, discover new events and days to share with the general public.

## What is your track record for delivering high quality arts and culture activity?

For the past 4 and half years 57North has continuously occupied a physical space in the center of the city, providing facilities to our membership and the public. We provide a location with tools and equipment, such as a 3D printers, and share our expertise and knowledge in the use of our toolset for the benefit of our membership and the general public.

We recently moved from a single room space on Union Street to a larger multi-room space opposite the central library. This move was entirely self-funded and is a good example of our ambition combined with focus on financial sustainability. We believe the increased floor space, and location in the cultural heart of Aberdeen will help us reach a wider audience and grow in a very positive way.

Over a number of years our membership have collaborated with students from Grey's School of Art, assisting in providing novel technological solution to aid the implementation of art installations and projects, this assistance provided a greater scope for creative experimentation, and mutual learning and development experience.

We have regularly participated in events in the city including Mayfest, TechFest, and events in partnership with the IET and Science Centre, We have also collaborated with the University of Aberdeen, Robert Gordon's University and Make to provide workshops and presentations.

We currently work with the Open Rights Group to provide a monthly session, called "Cryptonoise" focused on teaching any interested individuals or organisation the fundamentals and advanced aspects of personal digital & information security, using technologies such as encryption to secure and store information, and to promote understanding why personal phone, computer and network security are critical in the modern digital age.

We have been running a series of workshops and public lectures with Robert Gordon's University centred on our Air Quality Monitoring project, a collaboration with a team in Stuttgart. These have resulted in local members of the public installing sensors at their house, and becoming engaged in the project, moving on to investigate how to best provide data to local organisations for analysis and how to improve the hardware and software within the monitoring unit.

We currently work with the Open Rights Group to provide a monthly session, called "Cryptonoise" focused on teaching any interested individuals or organisation the fundamentals and advanced aspects of personal digital & information security, using technologies such as encryption to secure and store information, and to promote understanding why personal phone, computer and network security are critical in the modern digital age. We have provided this workshop to external organisations, including Radical Independence, Aberdeen Anarchist Group, Anarchist Federations and the Aberdeen Uni Computing science Society and offer the workshop in our space to members of the public free of charge, and have done for a number of years.

Our other events, for example the Game Jam and Open Street Map hacking day have proved popular and attracted visitors from around both Aberdeen and Scotland to participate.
